LYNDHURST PRE-KINDERGARTEN AND KINDERGARTEN REGISTRATION

Joseph Abate, Jr., Superintendent of Schools, has announced that Kindergarten registration for the Lyndhurst Public Schools will be held Wednesday, February 10, 2010 and Friday, February 12, 2010 at the **Lyndhurst Board of Education office, 420 Fern Avenue from 9:00AM--11:00AM and from 1:00PM--3:00PM.**

Students who will be five years of age by October 1st, or up to seven years of age and entering the public schools for the first time, may register for Kindergarten at the Board Office during this time.

PLEASE NOTE: STUDENTS PRESENTLY IN PRE-KINDERGARTEN IN THE LYNDHURST SCHOOL SYSTEM DO NOT HAVE TO REGISTER FOR KINDERGARTEN.

Children within these age limits are to be registered and admitted only once during the school year, and then only until October 1.

Parents of children born between October 2, 2005 and October 1, 2006 may register for Pre-kindergarten Wednesday, February 24, 2010 and Friday, February 26, 2010 from 9:00AM-11:00AM and from 1:00PM-3:00 PM.

The following information is needed to register: Birth Certificate, Record of Immunizations (current physical exam required prior to 9/1/10), Custody papers (if applicable), Proof of Residency (**3 DOCUMENTS ARE REQUIRED**): 1) Deed or Proof of Mortgage; OR Lease or Rent Receipt; 2) Utility bill; 3) Driver's License (preferred) or another form of identification showing Lyndhurst residency.

Students entering the Lyndhurst public schools for the first time are required to present documentation of a current medical examination and required immunizations. Physician's examination forms are included in the registration packets. Please check that your kindergarten age child has had his/her last DPT or polio booster after their 4th birthday. Additionally, every child born after January 1, 1990 will be required to have received three (3) doses of the Hepatitis B vaccine, and every child born on or after January 1, 1998 will be required to have received one dose of the varicella (chicken pox) vaccine prior to entry into Kindergarten.

The following are two of the requirements for children entering Pre-Kindergarten:

1. Every child 12 months through 59 months of age enrolling in or attending a preschool facility or licensed child-care center on or after September 1, 2008, shall have received at least one dose of PCV (Pneumococcal conjugate Vaccine) on or after their first birthday.

2. Children six months through 59 months of age attending any preschool facility or licensed child-care center on or after September 1, 2008, shall annually receive at least one dose of influenza vaccine between September 1 and December 31 of each year.

You will be required to present documentation of the above vaccination requirements and a physical examination by a medical physician in September prior to the 2010-2011 school year.

Registration packets will be available at the board of education office, 420 Fern Avenue., 2nd Floor on January 15, 2010. Parents are urged to pick up prior to registration dates; however, they will be available at the time of registration. **THEY MUST BE RETURNED IN PERSON DURING REGISTRATION WEEK. (CHILD NEED NOT BE PRESENT)**
